## Installation instructions CMM Check

Dear customer,

you have ordered the CMM Check software at Hexagon or you want to perform a test installation.

The software may only be installed on a **64-bit computer** with **Windows 10 or higher** and a **compatible version of PC-DMIS**. For compatibility notes, please refer to the section: [Compatibility of PC-DMIS with CMM Check](#) in this installation guide. No software tests have been performed under other operating systems. If this software is installed under other operating systems, no guarantee can be given for the full functionality of the software.

In addition, the **.NET Framework version 4.7.2** or higher is required on the PC.


The use of the software is subject to acceptance of all provisions contained in the software license agreement. For details, refer to the document "EN\_EULA.pdf", which you will find in the same folder in which the user manual is located.

Please perform the following steps to install the software on your PC-DMIS computer:

1. Check the PC-DMIS version currently being used.
2. Start the download via left click on the file.
3. Unpack the zip archive on your PC-DMIS computer.
4. Start the setup.exe with administrator rights to install the software. Then follow the instructions in the set-up procedure.
5. After successful installation start PC-DMIS with administrator rights.
6. Start CMM Check with administrator rights via the related Windows start group. If there is no license file, a dialogue for a license request will open:

7. Fill in the mandatory fields on the left side. Decide between "License with time limit (demo)" (valid for a maximum of 3 months), "License with time limit (subscription)" (purchased license with a time-limited validity) and "License without time limit" (purchased license without a limited validity) by selecting the corresponding radio button on the right side.
8. If "License with time limit (subscription)" or "License without time limit" is selected, the "Order number" field appears. Enter the order number. This can be found in the Hexagon order confirmation. Alternatively, the number of the customer order can be entered.
9. You can then save the license request with the <Create file> button.
10. Please send the license request to [DESoftwareWETZLAR@hexagon.com](mailto:DESoftwareWETZLAR@hexagon.com).
  - If you already have a license and it is no longer valid (e.g.: after update or PC exchange), please send it to the above email address in addition to the license request.
11. You will receive an e-mail with the license file within 24 hours (on working days).
12. Copy it into the installation directory of CMM Check.
13. Start PC-DMIS and CMM Check once with administrator rights.
14. You can then use the software with user rights. Both PC-DMIS and CMM Check must be started with identical permissions.

## Required access rights

PC-DMIS and CMM Check requires full access to the areas described below in the file system and registry:

### CMM Check:

#### Registry:

- "HKEY\_CLASSES\_ROOT\PCDLRN.Application\" and all subkeys
- "HKEY\_CURRENT\_USER\Software\VB and VBA Program Settings\" and all subkeys

#### File system:

- Installation directory and subfolder
- "C:\Users\Public\Documents\Hexagon\PC-DMIS CMM Check\" and subfolder



## PC-DMIS:

### Registry:

- "HKEY\_CLASSES\_ROOT\PCDLRN.Application" and all subkeys
- "HKEY\_CURRENT\_USER\Software\Hexagon\PC-DMIS" and all subkeys

Optional:

- "HKEY\_LOCAL\_MACHINE\SOFTWARE\Wow6432Node\Hexagon\PC-DMIS" and all subkeys
- "HKEY\_USERS\.\DEFAULT\Software\Hexagon\PC-DMIS" and all subkeys

### File system:

- "C:\ProgramData\Hexagon\PC-DMIS" and subfolder
- "C:\Users\Public\Documents\Hexagon\PC-DMIS" and subfolder
- „C:\Users\{user name}\AppData\Local\Hexagon\PC-DMIS\{PC-DMIS version}“ and subfolder
- User-defined folders, in which measuring routines, probes, subroutines etc. are stored

## Compatibility of PC-DMIS with CMM Check

CMM Check is backward compatible to the last 5 PC versions.

Example:

- Version number CMM Check: 2024.1
- Compatible with PC-DMIS version: 2019.1 or higher

## Use of the software as a "License with time limit (subscription)"

The software can usually be used for a period of 12 months. A corresponding notice is given in good time before expiry. An extension of the software use must be requested by the customer from the respective contact person at Hexagon. Hexagon will send a corresponding offer, which must be ordered in writing by the customer. Longer usage intervals can be agreed separately at any time.

## Other notes on CMM Check

Please note that the license request is really generated on the computer intended for the software.
